

Investment objective

The Company’s investment objectives are to achieve a high, secure dividend yield on its investment portfolio and to realise long-term growth in the capital value of the portfolio for the benefit of shareholders while taking care to preserve Shareholders’ capital.

Manager’s comments

The Company’s NAV total return and share price were down 2.8% and 3.1% respectively in July, in a highly volatile month. Long-duration assets like infrastructure and utilities were particularly hit in the last days of July as US Treasury yields steepened sharply after the FED’s decision to leave rates unchanged. For context, the S&P Global Infrastructure Net TR Index and the MSCI World Utilities Net TR Index returned -1.3% and -2.9% respectively, all in Sterling terms. The month of July was affected by the resumption of US-Iran hostilities and a cautious monetary policy backdrop, which overshadowed the start of a solid Q2 earnings seasons towards the tail-end of the month. The portfolio ended the month with gearing of 8.0% (versus 10.2% at end-June) after the manager reduced exposure in response to volatile and uncertain markets.

Calendar year-to-date, the Company’s NAV total return was 7.7% (as at the end of July), with the share price up 18%. The Company continued to trade at a premium to NAV throughout the month despite the market volatility.

North American holdings had the most adverse impact on the portfolio in July, but European names also contributed negatively overall. Brookfield Renewables Partners, Public Services Enterprise, American Electric Power and DTE were among the poorest contributors, alongside Spanish integrated utility Iberdrola and the UK’s National Grid. Conversely, Constellation Energy bounced c.4% after a tough first half of the year. Greencoat UK Wind continued its recovery rally, up c.10% in July. Germany’s E.ON was also a top contributor, up c.2% on the month. But the real surprise came from Chinese holdings China Suntien and China Water Affairs up c.11% and c.5% after both losing c.30% since their November 2025 highs. Fluctuating flows on the Hong-Kong equity markets have been the main driving factor for those names.

Q2 earnings season has so far delivered solid numbers for most European and US utilities, including some guidance upgrades. Environmental services and transportation infrastructure also had a solid quarter. Integrated European majors in the portfolio all delivered strong Q2 results with some companies such as RWE, Engie and Enel raising 2026 financial guidance, whereas others such as Iberdrola indicated scope for a guidance upgrade at Q3. In the same vein, Veolia completed its acquisition of US Hazardous waste company, Clean Earth, and raised 2026 guidance driven by very strong H1 results and a robust outlook for H2. North American holdings were not exempt from this trend, notably with NextEra and AEP reaffirming medium term high single digit earnings guidance, while Xcel provided visibility on another incremental \$10bn of capital expenditure relative to its existing \$60bn 2026-2030 investment plan.

Portfolio activity during July was selective and mainly focused on reducing exposure to uncertain markets by lowering the Company’s gearing. While a few positions were increased (SSE, Engie, RWE, NextEra), the manager mostly took profits on names that had performed well in the first months of the year, such as Veolia and E.ON.

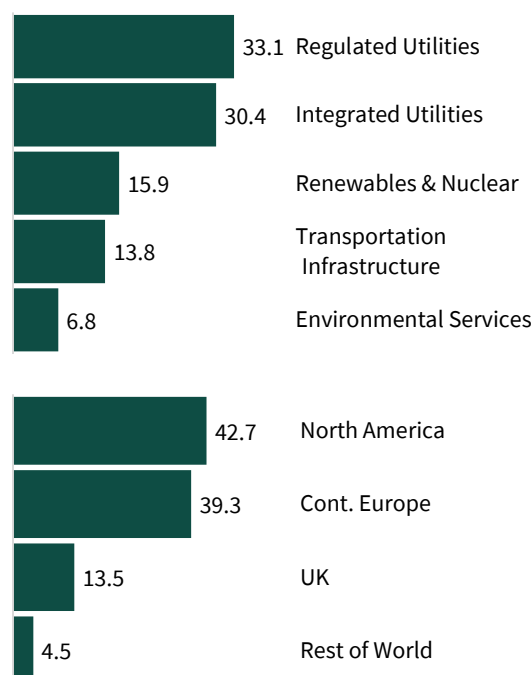
